BMW AG hereby announces that starting from 2025, BMW will recommend the use of R-M paint materials as well as all non-paint related products from BASF for paint repairs of BMW and MINI vehicles in the countries specified below.

The framework agreement between BASF and BMW regarding this recommendation runs until 2029 with a two-year extension option.

This recommendation letter is valid for 2026 and must be renewed annually.


